### **LEAGUE FEES**

### **ROSTERS**

Complete rosters signed by the Pastor and/or Principal, Coach, and/or Athletic Director, and if applicable, the CYF Director are required. These rosters must include first and last names of the players, their birth date, their Uniform Number and their address and school they attend. **Any waivers for the season must be included with the rosters.**

### **SCHEDULES**

Schedules will be drawn up during August. **Each school must inform the league in writing by the July 31st commitment date of any event which would cause schedule problems or conflicts, such as scouting camps, concerts, school plays, forensic meets, etc.** The league will make every attempt to work with the schools in drawing up the schedule. **There are no weekends off due to back-to-back scheduling requirements.** Everyone receiving a schedule is asked to check it over very carefully. This includes all host gym personnel. Not all teams play at the same time or day each weekend. Some teams may not be scheduled to play at all on a particular weekend, but very unlikely. Each team will play a total of 12 matches during the season.

Games cannot be scheduled before noon on Sundays.

Please inform Roger Lewicki of any discrepancies or conflicts as soon as possible.

### **CANCELLATIONS**

The weather advisories posted by the Milwaukee County Sheriff's Department will be strictly followed in the event of severe weather conditions. Volleyball Coordinators and host gyms will be notified by the League as early as possible in the case of cancellations. If a day's schedule is canceled for any reason, the League will determine the make-up date if possible. If not possible to reschedule final standings will be determined by winning percentages of teams.

### **COACHES**

Coaches must supervise players at all times whether in the immediate area outside the gym, inside the gym watching another match, or in the locker rooms prior to during, and after the scheduled match. Players may not be left unattended.
